Local Committee Meeting for Hosting the 16th YMCA Swimming Championship February 28, 1938 Detroit Athletic Club.

After reviewing the recommendations of the 1937 National Aquatic Conference held in Chicago, the entry material (Official Entry Blank Information & the Official Entry Blank) from the 1937 Championship Meet held in Chicago, and NCAA rules pertaining to hosting a championship meet and the order of events, the following recommendations were submitted to the National YMCA Aquatic Committee for approval, and any additional suggestions and/or corrections.

- That the meet be conducted in five periods: Friday forenoon; Friday afternoon; Saturday
 forenoon preliminaries; and the Saturday afternoon finals to be concluded by 6:00 PM.
 This recommendation was made so that all of the contestants and spectators could attend
 the combined Sports Festival at the Olympia Saturday evening. In addition the host
 committee would like to present the meet awards in a combined presentation ceremony at
 Olympia.
- 2. That the 1500 Meters Free Style event be added to the "Order of Events" this year. To be run on Friday morning as a time trial finals, at the Northeastern Branch YMCA (60ft Pool) in conjunction with the Fancy Diving.
- 3. That five places be awarded in the finals, even though the championship is being held in a four lane pool. That all events be run in time trial heats, the fastest four times (three watches on each man) qualify for the final heat, for place with the fifth fastest time placing fifth. The team points to be split in case of a tie. Exception: That the following procedure be recommended in running the 50 yard Free Style event. That all heats be selected by draw (heat & lane) for the preliminaries, that first places qualify for the semi-finals, and the top two in the semi-final heats qualify for the finals. That there is no seeding of the heats according to previous times. The fifth place point be awarded to the fifth fastest time in the semi-finals or maybe another heat of the semi-finals if they wish.
- 4. That the 3 meter diving be omitted from the championship, because there is not safe depth of water under the 3 meter board in the city in indoor pools.
- 5. That the 1 meter diving be conducted at the Northeastern YMCA pool, preliminaries and finals both Friday morning, with exhibitions by the finalists in the Friday night, and Saturday afternoon finals. That the host committee in see that an official 14ft board be procured and set a official height. That even though this event is removed from the center where the rest of the meet is being conducted, that is was that every detail be correct for the benefit of the diving competing.

CONDITIONS GOVERNING THE 1938 CHAMPIONSHIPS

<u>Rules:</u> The National Collegiate Athletic Associations Rules (1938) Edition) shall govern the competition with the omission of the 3 Meter Diving.

<u>Suites:</u> Contestants shall not be permitted to wear any other YMCA letters or insignia on any part of their suits or robes. No commercial or advertising insignia will be allowed. Tank suites must be warn for all events except diving. Trunks will be permitted for diving only.

<u>Awards:</u> Regulation National YMCA Championship medals for first, second and third places in each event including relays. A permanent trophy will be awarded the swinning team.

Entry Fees: \$2.00 per man must accompany each entry regardless of number of events entered. This includes a ticket for admission to the contestants' section at the Olympia Stadium for the final championships and closing spectacle on Saturday night, April 30th.

Dive Entries: A list of five optional dives must accompany the contestants entry blank. Any charge in dives must be made in writing before 8:00 P.M., Thursday, April 28.

Entries Close: At 12 o'clock noon Monday, April 18, 1938. Only those entries in the office of J.P. Lee, Downtown Branch YMCA Detroit at that time will be accepted.

Registration All players (swimmers and divers) must have their YMCA Registration Cards.

Conditions Governing the Championships Continued:

<u>Reporting</u>: All contestants must report to the Championship Committee not later than 8:00 AM. On the morning of Friday, April 29, 1938 at Registration headquarters at the Statler Hotel, Detroit, Michigan.

Padlocks: Contestants will be expected to provide their own padlocks for lockers.

<u>Publicity:</u> The Detroit Publicity Committee requests pictures of swimmers and records of individuals and teams for advance notice in Detroit papers. These should be sent immediately to P.J. Lee, Downtown Branch YMCA Detroit, Michigan.

<u>Championship Committee:</u> The National YMCA Aquatic Championship Committee will meet with the Executive Committee at 6:00 P.M. on Thursday April 28 to pass on eligibility and to consider all matters pertaining to the conduct of the championships.

Coaches Meeting: All coaches will meet with the Championship Committee and 8:00 PM., at the Downtown Branch YMCA on Thursday, April 28.

2—Meetings were held prior to the 1938 International/ National YMCA Championships: April 28, 1938 at 6:00 P.M. & at 8:00 P.M. 6:00 P.M. Championship Committee Meeting:

No protests concerning eligibility had been received by any member of the committee to date but differed closing the matter of eligibility until after a review of the team entry lists presented to them at the coaches meeting at 8:00 PM. Then they reviewed the "National Rules that Govern YMCA Sports" and it was agreed that they would follow the recommendations of the coaches at the 1937 "that there would be no seeding in the 50 Yard Free Style. A blind draw for heats and lanes would be conducted and the 1st place finisher in each heat would qualify the the Semi-Final heats. Then the top 5 times would swim for the championship. Cureton appointed J.E. McColley to preside at the Aquatic Luncheon to be held Friday Noon at the Fisher YMCA. He asked Gillesby to report all of the details related to set up and conduct of the meet (special arrangements officials and events) to the coaches at the meeting to follow.

8:00 P.M. Coaches and Officials Meeting:

Present: Chairman T. K. Cureton; J.E. McColley, Harrisburg, PA; George Gillesby Detroit Fisher Branch YMCA; Matt Mann Referee University of Michigan; Larry Lambert Fisher Branch; H.S. Henrici Tulsa; Ernest Smith, Fisher Branch; Carl Nelson Lawson Branch; Robert Dillon Clinton, IA; Harold Beach, Central Pkwy, Cincinnati, OH; Gerald Rudig, Huntington; Ray Hubsch, Pittsburg-Center Ave; Eugene Schwan, Ft Wayne. Matt Mann was introduced as the meet referee by Chairman Cureton, and it was explained that he would be the conductor of the meet under the rules of the National Inter-Collegiate Athletic Association, but that the Championship Committee would be the final authority in all matters outside the actual conduct of the events themselves. Mr. Gillesby announced the list of officials and asked for a few more volunteers from among the coaches.

<u>16thYMCA International/National Championship Meet Continued:</u>8:00 PM.Coaches and Officials Meeting Continued:

Chairman, Thomas Cureton, asked the group to review thoroughly the listed entries, and raise any questions regarding eligibility. Only one question was raised by Huntington regarding Clark and Ogle of the Fisher YMCA competing in the Windsor AAU meet. Coach Lambert of Fisher explained satisfactorily to the committee. Chairman Cureton then announced that if there were no further challenges the matter of eligibility was finally closed, and no further challenges might be entered against a team. The change of place for conducting the 1500 meter was announced and the reasons explained. The coaches agreed the event should be conducted at Northwestern High School starting at 10:00 AM. Mr. Gillesby explained that the necessary blanks for requesting records would be on hand, that the watches were certified and the pools officially measured. The drawing for heats and lanes for all events followed. The meeting adjourned at 11:10 PM.

Special Note: This was the 1st year for the 1500 Meter Free Style event into the National Championship "Order of Events." Due to the number of entries in the 1 meter diving and the 1500 Meter Free Style it was determined that 2 pools were needed to finish these events in a timely manner and not to so that the other preliminary events would start on time that afternoon. The 1500 Meters was held at Northwestern High School and the Diving in the Northeastern Branch YMCA pool.. The distance for the event was officially measured by the City Engineering department and it was to be <u>65 lengths plus 15 yards</u> and 1.25 feet. Unfortunately the pool was not set up properly (30 Feet short) which was an unfortunate error that was not discovered until after the event was conducted. The time was corrected from 20:21.7 to 20:29.2.
